PAYMENT- Full payment is due within 24 hours of receipt of the invoice. Only wire transfer, credit cards, and PayPal are accepted payment methods (NO EXCEPTIONS). A 2.5% PAYMENT PROCESSING FEE MAY APPLY TO CREDIT CARD PAYMENTS. All sale prices are in US Dollars unless listed otherwise. The maximum credit card payment allowance is \$10,000 USD. All items will be shipped as seen in the auction and/or auction photos. Should the Seller agree to undertake dismantling work, the Purchaser is responsible for paying all fees associated with dismantling.
