Upon failure of the Buyer to collect goods within SEVEN BUSINESS DAYS, the Seller shall have the option in its sole discretion of removing and storing the purchased items at the expense and risk of the Buyer or may resell the purchased items without notice at public sale or otherwise dispose of goods at the sole risk and expense of the Buyer.
