ALL MATERIALS OFFERED FOR THE SALE (the "items") ARE LOCATED IN RENO, PA. INSPECTION MAY ONLY TAKE PLACE BY APPOINTMENT ONLY. 1. REMOVAL: All items must be picked up within SEVEN BUSINESS DAYS of the sale. The Buyer is responsible for removal of item(s). Items can only be removed once full payment is received. Buyer shall prepare items for loading onto their transport; F.O.B. on site. All payments must be made through the Aucto Payment Gateway (APG). Buyers have below options to send payments: - Wire Transfer - ACH - Automated Clearing House (US) - EFT - Electronic Funds Transfer (Canada) - Credit Card (ONLY available for sale orders less than 5000 USD) - Instructions will be available via APG to winners after a sale has concluded. Aucto will NOT accept Cash, Check, E-Check, Cashier's Check or Bank Drafts as payment options. Unless specified by the seller in the "Sale Terms", all payments are due within 24 hours of a sale order being delivered.



## Removal Terms:

Removal: All items must be picked up within five business days of the sale. Items can only be picked up or shipped once full payment is received. Items can only be picked up during Voyten's business hours of 8:30 a.m. and 4:00 p.m. Monday through Friday unless other arrangements are made. Seller will prepare items for loading onto buyer's transport. We can supply freight quotes per request of buyer. If a buyer fails to pick up purchased items within the five business days the seller shall have the option to apply a storage fee of \$25 per day for up to thirty days after the sale date. Failure to pick up order within thirty days will result in a 20% cancellation fee of the total sale price.
