Terms of Sale: • All items are sold as is where is – No Warranties No Guarantee's • Buyers must make payment within 24-48 hours of receiving their invoice. • Buyer must arrange logistics within 10days once payment has been made. Failure to pick up equipment in scheduled timeframe with seller will result in abandonment. No refund will be issued! • If equipment is not picked up within the timeframe set by the seller, Buyer will forfeit all goods and monies.

Payment Terms:

All payments must be made through the Aucto Payment Gateway (APG). Buyers have below options to send payments: - Wire Transfer - ACH - Automated Clearing House (US) - EFT - Electronic Funds Transfer (Canada) - Credit Card (ONLY available for sale orders less than 5000 USD or 5000 CAD) - Instructions will be available via APG to winners after a sale has concluded. Aucto will NOT accept Cash, Check, E-Check, Cashier's Check or Bank Drafts as payment options. Unless specified by the seller in the "Sale Terms", all payments are due within 24 hours of a sale order being delivered. Please submit tax exemption forms to payments@aucto.com with your sale-order number in the subject line. Local tax laws may apply to Aucto Buyer's Premium (Aucto BP or ABP). Removal Terms:
